- Mr Greaves complained about how council meetings are conducted but he was assured that they are conducted in compliance with Local Government Acts and within the lawful and recommended framework for parish council meetings.

- QEII Field: -Fields in Trust a royal oak sapling has been received and is to be planted on the recreation field.
- Land registration: ownership of some of the land around the Memorial Hall has been investigated and some further information that has been sent to Bannister Bates Conveyancing Lawyers
- Manor Lane play area- a seat paid for by the Plymouth Brethren is to be put in place. The Council will
 take on the responsibility for maintenance and insurance. Lancaster City Council has agreed to repair a
 seat already there and tree trunks, as play features, are to be installed
- Mr Alan Sledmore has decided to retire from guiding walks across the Bay after August 2013. Five charity walks are to be held during the summer.
- Local Government Boundary Commission, Electoral Review of Lancaster -details have been circulated for members and any comments requested
- NHS Lancashire Controlled Locality Rurality Review of services -details have been circulated for members and any comments requested

Precept: it was confirmed that a request has been made to Lancaster City Council for a precept of £30,090 plus £1660 compensatory grant to cover the predicted expenditure for 2013/14. The resulting parish tax rate (on a Band D property) will be £23.96

Review of the Financial Regulations of the Council and Financial Risk Management -copies of the documents have been provided to all councillors for examination. The Financial Risk Assessment and Management

Register has been updated and minor amendments made.

1844 Open Spaces

Recreation Field project: Recreation field development -Lancashire County Council arranged the jetting of the gullies and some defects were found. The Chairman and clerk had a further meeting with the contractor, landscape architect and Lancashire County Council Project Officer about the drainage and it was decided that further investigation is necessary. The cost of this is being sought.

A request has been made to Carnforth Rotary Club for a grant towards the recreation field project. EDF has still not responded to a grant request.

Work on the tree at the side of Memorial Hall to reduce interference with a satellite television dish: Mr Peter Walton (Tree Surgeon) has been consulted and it was decided to take his advice and to have the necessary small branches removed.

1845 **Burial Ground**

Consideration of work to be done at the entrance: the building of the wall on the right hand side has almost been completed. The re-alignment of the wall on the left hand side is to be looked at as agreed in the planning permission. The filling in and resurfacing of an area adjacent to the highway will be necessary. It was agreed to seek a cost of this work. Due to funding constraints the whole project of improving the driveway and construction of a car parking area will need to be done piecemeal.
